- Fixed an issue when Parallels ConfigMgr Proxy would not start when VPN boundary is configured in SCCM
- Fixed an issue when configuration profiles could not be installed via Parallels MDM on a Mac in a secondary SCCM site in some cases.
- Fixed an issue when a VPP application could not be installed on a Mac in a secondary SCCM site in some cases.

- In rare cases, a user was not prompted whether to proceed with the installation of a software package if the installation required administrative rights.

- Fixed an issue when only the current user was shown in the list of users allowed to unlock a FileVault2 encrypted disk in macOS 10.13-10.14.
- Apple DEP enrollment was not working in some cases.

- In some cases, the status of a failed software package installation was reported as "In progress".
- In some cases, unnecessary warnings were added to the MP\_Hinv.log file when collecting the hardware inventory.
- The Parallels Problem Report utility was not installed with Parallels IBCM Proxy component.
- In rare cases, Parallels SCCM Proxy was crashing when registering new Mac clients.

• Added support for macOS 10.14 Mojave.

#### Improvements and fixes:

- Changed minimum requirements for .Net from v3.5 to v4.0.
- "Set Variable" step was failing when executing non-OSD task sequences.
- "Join Domain" step was failing with the error "Unable to decrypt" when executing non-OSD task sequence in PKI-enabled environments.
- Parallels Mac Client was crashing while executing non-OSD task sequence if Parallels Proxy was unreachable.
- It was not possible to activate Parallels Mac Management on SCCM with TLS 1.2 enabled.
- "Required" and "Installed" statuses of the Apple software updates were not displayed in SCCM.
- FileVault 2 encryption status was reported incorrectly for Mac computers equipped with T2 chip.
- In rare cases, Parallels Mac Client was crashing while installing multiple software packages, applications, and task sequences at once.
- Subsequent prompts to turn on the required FileVault 2 encryption weren't shown to the Mac users if they cancelled the first prompt and then rebooted the Mac.
- Software packages with postponed installation prevented other packages to start their installation.
- In rare cases, a Mac user was prompted to re-register Parallels Mac Client if several attempts to connect to Parallels Proxy had failed.
- The Install Application dialog didn't show up for required application even if it was configured to display all notifications, making it impossible to postpone the installation.
- Recovery partition was copied twice when creating a NetRestore image for OS deployment.

## Parallels Mac Management v7.0.3 Hotfix 3 for Microsoft SCCM build PMA2012-7.0.3.1 (August 13, 2018) includes a fix to the following issue:

• Configuration of Parallels ConfigMgr Proxy may fail if SCCM Microsoft SQL Server is configured to use TLS 1.2.

Parallels Mac Management v7.0.2 Hotfix 2 for Microsoft SCCM build PMA2012-7.0.2.1 (July 10, 2018) includes a fix to the following issue:

• The Parallels MDM service would not work under a non-privileged account.

• Parallels ConfigMgr Proxy cannot be configured if the SCCM database name is not the default name.

- Fixed an issue when task sequence step "Format and partition disk" was failing on APFS volumes.
- Fixed an issue when applying macOS image captured from HFS volumes was failing on APFS volumes.
- Fixed an issue when Parallels Mac client could change the system software updates catalog URL, even if it was configured by a third-party software.
- Fixed an issue when it was not possible to connect via SSH to a Mac computer that was booted from the network using a boot image captured from macOS 10.13 with enabled SSH access.
- Fixed an issue when MDM enrollment profiles with attached configuration profiles containing certificates could not be assigned to Mac computers.
- Fixed an issue when some Java update applications were not recognized as installed causing the dependent task sequence steps failure.

This is an initial release of Parallels Mac Management Prerequisites Checker v6.1 (build PMM-Prerequisites-Checker-6.1.0.22). The Prerequisites Checker allow to check readiness of an SCCM infrastructure for Parallels Mac Management v6.x deployment.

## Parallels Mac Management v6.1 for Microsoft SCCM build PMA2012-6.1.0.22 (October 10, 2017) includes the following new features:

- Support for macOS 10.13 High Sierra.
- The Problem Report dialog now displays the hostname of the Mac computer from which the report has originating.

#### Parallels Mac Management v6.1 for Microsoft SCCM (build PMA2012-6.1.0.22) includes improvements and fixes to the following issues:

- Configuration settings for Parallels Desktop 12.1.2 (41525) and its virtual machines would not apply via Configuration Baselines.
- A dialog with a prompt to restart the Mac was not shown after an interactive software installation in some cases.
- The Published Date value was incorrectly formatted in Parallels Application Portal if Canada or UK was set in System Preferences > Language and Region.
- Publishing of software updates was failing with error "The actual length is greater than the MaxLength value" in some cases.
- Applying a baseline with the FileVault 2 configuration item was failing for domain users.
- Parallels Mac Client would fail to connect to Parallels Proxy in some cases.
- A link to the Parallels Mac Client installation package was not updated during Parallels MDM server reconfiguration.
- The deployment status for an installed software distribution packages in SCCM 1606 was reported as "Unknown".

## Parallels Mac Management v6.0 Hotfix 1 for Microsoft SCCM build PMA2012-6.0.1.2 (August 31, 2017) includes fixes to the following issues:

- Parallels Task Sequence Wizard may fail to authenticate if LDAP signing is enabled.
- Format and Partition Disk TS step fails if the target volume has CoreStorage partition.

## Parallels Mac Management v6.0 for Microsoft SCCM build PMA2012-6.0.0.87 (July 24, 2017) includes the following new features:

- Ability to Wipe and Lock a Mac remotely.
- Support for Software Metering.
- Custom Settings payload added to the built-in Configuration Profile Configuration Item editor.
- Support for Maintenance Windows for software and Apple software update deployments.
- Support for Assignment Schedules for software deployments.
- New and updated Task Sequence steps:
  - ♦ Install Application step added.
  - ♦ Format and Partition Disk step added.
  - Apply OS X Image step now includes an option to configure the destination partition.
  - ♦ Join Domain step now includes an option to configure a confirmation before creating a mobile account.
- Task Sequence editor supports copy and paste of steps between task sequences.

• Parallels Mac Client can be automatically migrated to a new SCCM installation during the migration from the old SCCM infrastructure to the new one.

#### Parallels Mac Management v6.0 for Microsoft SCCM build PMA2012-6.0.0.87 includes improvements and fixes to the following issues:

- Parallels Mac Client running on OS X 10.11.5 crashes when processing the Mac App Store Update for OS X El Capitan (091-10728).

# Parallels Mac Management v2.0 RTM Hotfix 1 for Microsoft SCCM (builds PMA2012-2.0.1612.924788 and PMA2007-2.0.1611.924774) includes numerous fixes and updates. The details are provided below.

*Updates to the Mac OS X Configuration Profile functionality* 

- Fixed an issue when the profile editing dialog wouldn't open an existing profile if the Security & Privacy payload was already defined in it.
- Fixed an issue when the Mac Agent would unexpectedly remove a successfully applied configuration profile from a Mac.
- Fixed an issue when instead of the latest revision, all existing revisions of a Mac OS X configuration item would be applied on a Mac [SCCM 2012].

Updates to the Mac OS X Deployment functionality

- Fixed an issue in the Add OS X Operating System dialog that made it impossible to specify a path to the ".nbi" folder containing the NetBoot.dmg file.
- Fixed an issue when an OS X image distributed to the NetBoot server would not be updated without the NetBoot service restart.
- Fixed an issue when it was allowed to install a NetBoot server on a computer with PXE disabled [SCCM 2012].
- Fixed an issue when only a single OS X image would be shown on a Mac during the EFI boot (the Alt key pressed) despite the fact that multiple task sequences were created and deployed in the Configuration Manager console.

• Fixed an issue with the NetBoot service crashing on exit.

Update to the Mac hardware inventory collecting

• Fixed an issue with System Profiler crashing on a Mac after the Mac Agent was installed on it. The issue caused the Mac hardware inventory information not to appear in the ConfigurationManager console.

*Updates to the Software Distribution functionality* 

- Fixed an issue with the ".pkg" directory packed into the ".dmg" file not installing during Software Distribution via the \*dmg/\*pkg:: command.
- Increased the timeout for the ".dmg" image mounting procedure during Software Distribution to accommodate large packages.
- Fixed an issue with a ".dmg" package containing Symantec Endpoint Protection failing to install.
- Fixed an issue with an OS X update package not being delivered to Macs.

Update to the unattended installation script

• Updated the InstallAgentUnattended.sh script to have UNIX end-of-line characters, so it could properly execute in Mac OS X.

Windows Server 2003 related updates

- Fixed an issue with the Parallels Management Suite for SCCM 2007 installer refusing to install the Proxy and the NetBoot server on Windows Server 2003 SP2.
- Fixed an issue with the Proxy configuration wizard not working properly on Windows Server 2003.

Secondary sites related updates

- Fixed an issue with the Configuration Manager Proxy using a wrong management point. A management point on a secondary site must be used when there's just one Proxy on the primary site, but several management points (primary and secondary) exist.
- Fixed an issue when it was allowed to assign a different site code to an existing Configuration Manager Proxy when another Proxy instance was already using that side code.

# Parallels Mac Management v2.0 RTM for Microsoft SCCM (builds PMA2012-2.0.1494.914094 and PMA2007-2.0.1536.914681) includes the following improvements:

- Ability to deploy Mac OS X images via SCCM to Macs.
- Ability to deploy Mac client software and enroll a Mac silently via command line.
- Added Mac client widget to System Preferences in Mac OS X.
- Implemented the ability to fine-tune network discovery for Macs.
- Implemented support for secondary SCCM sites.
- Ability to customize ports used for communication between Mac Agents and the Configuration Manager Proxy service.
- The Configuration Manager Proxy service has been enhanced with role-based security for access to its functions.
- Improvements to the built-in Mac OS X configuration profile editor and other configuration profile related functionality.
- Added an integrated uninstaller to the Mac Agent application package.

This release also includes the following fixes:

- Fixed an issue with Mac Agent crashing on reboot after a manual registration.
- The "Enter" key now works in the Mac Agent registration dialog when it is pressed on the "Password" field.
- The Configuration Manager Proxy configuration utility now removes duplicate SPN records from Active Directory.
- Problem Monitor is now started immediately after the configuration of the Configuration Manager Proxy is successfully completed.

- Fixed a potential issue with Mac Agent failing to enroll a Mac into SCCM if there are multiple Active Directory domain controllers present.
- Fixed a potential issue with Mac Agent failing to enroll a Mac into SCCM if there is a large number of SRV records in DNS for a domain.

- A new Mac OS X configuration profile dialog has been added to the Configuration Manager console.
